### **Directions to venue:**

From the North & South

Exit M6 at junction 32 – M55 sign posted Blackpool/Fleetwood

Exit M55 at junction 4 – A583 sign posted Stanley Park/Zoo/Hospital

At end of slip road take 3<sup>rd</sup> exit (right) and continue to 4<sup>th</sup> set of t/lights turn Right (A587) sign posted Zoo/Victoria Hospital. (BEWARE speed camera after 2<sup>nd</sup> set t/lights)

Continue through 1 set of t/ lights to mini roundabout and bear RIGHT (East Park Drive - BEWARE there is a speed camera on left between lights and roundabout)

Continue through 5 sets of t/lights (including pedestrian) to roundabout; take 2<sup>nd</sup> exit (straight across) onto dual carriageway (St Walburgas). Continue to next roundabout and turn Left onto Grange Road, Kingscote Drive is 4<sup>th</sup> on the left follow the road round to the park entrance.

### Classifications

A classes are for teams who are working towards earning their Level titles.

B classes are for teams that have earned their Level title in the A class.

*To gain a title in any level a team must qualify three times under two different judges*

NB: Once a team has earned their Level title in the A class, they may continue to compete in each Level they have titled in, but must do so in the B class.

IE: a team who has never competed or has not earned a title must enter level 1a.

However a team that has titled in level 1a can carry on competing in level 1, in the b stream, they can also compete in level 2a.

### TRIAL RULES & REGULATIONS

1. In the event that the trial is cancelled due to unforeseen circumstances, the hosts will refund fees, less reasonably incurred expenses, on receipt of a SAE submitted within 1 month of the show date.
2. APDT UK Rally rules & regulations apply to the whole event and all people and dogs must comply with these at all times. All competitors should familiarise themselves with the rules prior to the event. These are available under UK Rally at [www.apdt.co.uk](http://www.apdt.co.uk) and an abridged version is included below for your convenience.
3. Dogs must be registered with APDT UK Rally or the Kennel Club in order to be eligible to compete for APDT UK Rally titles - registration form available as in (2) above. All dogs must be shown at all levels of APDT Rally by the owner or handler registered with the APDT.
4. Dogs must be shown in a flat buckle or snap collar, a properly fitted limited-slip collar, or standard harness. The APDT does not allow the use of correction collars in the ring - choke chains, slip collars and prong collars are not allowed, nor are head halters or "no-pull" harnesses.
5. A dog that in the officiating judge's opinion exhibits threatening behaviour towards a handler, judge or any other persons or other dogs while in the ring will receive a non-qualifying score and be excused from the ring and the show site. Refusal of the handler to comply shall result in permanent removal of that dog and that handler's APDT Rally eligibility.
6. Any dogs exhibiting signs of aggression that threaten the safety of other dogs or humans shall be excused from the competition at the discretion of either the judge or the Trial Host. If the trial official believes that it is necessary in order to ensure the safety of others, he/she shall request that the dog be removed from the trial site or confined in such a manner as to remove the threat to others. Refusal by the handler to comply shall result in permanent removal of that dog and that handler's APDT Rally eligibility.
7. The owner of any dog that exhibits without provocation a reported threatening behaviour anywhere on the show site will be issued a written warning from the APDT Rally office. A second warning will result in permanent suspension of the dog's APDT Rally eligibility.
8. Judges may excuse any handler who delivers a correction while in the ring.
9. Representatives may excuse any person who delivers a correction while outside the ring.
10. Competitors are provided with a 30 minute period at the beginning of the event during which to walk the course (without dogs) and ask the judge questions. A second opportunity, will be given to walk the course at lunch time for late arrivals.
11. The judge must excuse any dog that goes lame while on course, eliminates in the ring or demonstrates illness such as vomiting.
12. Judges must excuse a dog if it is brought into the ring with bandages, stitched or taped in any manner. The dog may not be brought back into the ring later, even if the bandages have been removed.
13. Exercise modifications must be registered with APDT Rally, and accompany Trail Entry Form.
14. Female dogs in oestrus may not compete.
